### Sales Agreement

This warranty/contract is valid date of sale \_\_\_\_\_ to \_\_\_\_\_. After this date, warranty is expired. The seller agrees to deliver to the buyer a French Bulldog puppy with no symptoms of infectious or contagious life threatening disease for 7 days after dog leaves sellers' home. The buyer agrees to pay for a licensed veterinary health examination and obtain a health certificate within 7 days of taking possession of the puppy. The buyer agrees to forward the written veterinary health certificate to the seller. The terms and conditions of this contract are not effective until the seller has acknowledged receiving the certificate, failure on the buyer's part renders this warranty null and void. The buyer agrees to assume any financial responsibility for this examination, veterinary expenses and/or medications are not covered in this contract. Seller will not be responsible for any injury, illness, or loss due to the owner's treatment or lack of proper care. We do not cover, as they are considered normal to this breed: cherry eye, entropion, umbilical or inguinal hernia, loose hips, hip dysplasia, knees, allergies, trachea or palate issues, tail abnormalities, stenotic nares, retained testes, parasitic infections, kennel cough, respiratory or fungal infections, parasites, bacteria or viruses, dysfunction, demodectic mange and other autoimmune disorders. The seller does not assume responsibility for any reaction to any vaccination. The seller does not assume responsibility for any medical expenses incurred associated with any health problem. This guarantee does not apply to any physical problems which could be the result of an injury. This guarantee does not apply to the presence of deafness or any kind of hearing problems. This warranty covers fatal and life altering defects such as, spinal, heart, pancreas, kidney defect of a life-threatening nature. If the French Bulldog puppy dies within this contract's effective period, the buyer agrees to assume financial responsibility for an autopsy on the puppy, to be performed by a licensed veterinarian to determine the cause of death. Buyer agrees to forward the written autopsy report to the seller. If the cause of death is found to be any affliction listed in what this warranty does cover, the seller agrees to replace the puppy with one of equal value. A puppy eligible for replacement, must be returned or euthanized with prior permission from the seller to qualify for replacement. The returned puppy must appear in good condition to the seller, other than the specified problem. A puppy

will not be eligible for replacement if it has been or appears to have been neglected, abused, bred, or euthanized without prior permission from the seller. The buyer agrees to assume financial responsibility for all transportation costs incurred for transporting the returned puppy to the seller. Buyer agrees that there is no monetary refund of any kind, full or partial guaranteed or implied. The puppy must exhibit the congenital defect within the effective period of this contract. The buyer agrees to notify the seller of the problem as well as furnish veterinary reports by licensed veterinarians stating the affliction within two business days of the problem's discovery.

If puppy is being sold as limited AKC/pet only, puppy/dog should never be bred. If puppy/dog is bred there will be a penalty fee of \$16,000 USD for females and \$5000 USD for each breeding a male has complete. Buyer must spay or neuter puppy/dog before 18 months of age. Buyer must send proof of spay/neuter to Breeder. We will accept the bill that states that puppy/dog has been spay/neuter or statement for your Veterinarian. If puppy is being sold with Full AKC, buyer has full rights to produce and register their future litters. Seller does not guarantee puppy will be breeding quality, win in conformation, or performance events.

Puppy/dog should never be surrender to a shelter. If buyer can longer keep puppy, the puppy must be surrender back to the breeder. Breeder agrees to find a new pet home for puppy/dog.

Buyer has paid a non-refundable deposit of \$\_\_\_\_\_. Buyer is responsible to pay the balance by the time puppy is ready to be delivered, which is 8 weeks of age. If buyer does not pay the balance, buyer will forfeit deposit and any rights to the puppy. Buyer can make payment with Cash, Zelle, Paypal or Venmo. If paying by Paypal (goods & service) buyer is required to pay the surcharge fee. To avoid this fee, you can send Paypal friends & family.

Seller can transport puppy by ground transportation or by Air delivery for a fee
